Sub: Diversion of forest land (10.635 ha) for non-forest purpose under the Forest Conservation Act, 1980 for the work " Widening to two lane from 327/700km to 413/700 km of N.H-326(Erstwhile from 16/0km to 102/0km of S.H-25) under Vijayawada- Ranchi route in koraput and Malkangiri District of Odisha on EPC basis.

In inviting a kind reference to the subject & letter cited above, the diversion proposal of the above mentioned work is hereby resubmitted after necessary compliance as noted below.

- 1) The state serial number of the above diversion proposal allotted by the Additional PCCF (Forest Diversion & Nodal Officer, FC Act) is **OR – 01 /2017 Dt 12.01.2017**
- 2) Status of land as on 25.10.1980 has now been furnished in the proper format. Certificates from the concerned Tahasildars are attached herewith in the diversion proposal.
- 3) The abstract of Tree enumeration list has been corrected and attached.
- 4) The abstract of tree enumeration list is now furnished in the prescribed format and enclosed in the Diversion Proposal.
- 5) The composite diversion proposal pertaining to Forest division, Jeypore & Malkangiri is now submitted in a consolidated manner
- 6) The checklist of the diversion proposal has been properly maintained with page reference.
- 7) Conveyance of Gram Sabha proceedings in respect of the diversion of forest land for linear projects is not required as per govt notification no. **F.No. II-9/98-FC (pt) dated 15th January 2014** Of the Ministry of Environment & Forest,(FC Division) Govt of India. (copy enclosed). Moreover the proceedings of Gramya Sabha (in Odiya language) sought by the Collectors for FRA Certificates have been enclosed in the diversion proposal.
- 8) Site inspection report may kindly be furnished in the proper check list form at your end.
- 9) In authorization letter the signature of the authorized officer is to be attested at your end.
- 10) There was error in website entry which has been corrected by the DFO, Malkangiri. The details of enumerated trees are as follows :-


12) All the maps have been authenticated by DFO.

The composite diversion proposal after necessary compliance is submitted herewith in six sets for favour of kind information and further necessary action.






