In compliance of the Ministry of Environment and Forest (MoEF), Government of India's Letter No: 11-9/98-FC (Pt), Dated: 3rd August 2009 wherein the MoEF issued Guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 on the forest land proposed to be diverted for non forest purposes read with MoEF's letter Dated: 5th February 2013 wherein MoEF issued certain relaxation in respect to linear projects. It is certified that **4.90 hectares** of forest land proposed to be diverted in favour of the District Panchayat Raj Engineer, Nirmal for the construction of road from **R&B Road to Allampally** in Nirmal District falls within the jurisdiction of Allampally, Babanaik Tanda GPs in Kaddam Mandal of Nirmal District.

It is further certified that:

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **4.90 Hectares** of forest area proposed for diversion. A copy of records of all consultations and meeting of the Forest Rights committee (s), Grama Sabha(s), Sub Divisional committee(s) and District Level Committee(s) are enclosed.
- b) The Diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Grama sabha have given their consent to it.
- c) The proposal does not involve recognized rights of Primitive Tribal Groups and Pre-agricultural communities.
