Sub: Reply against the Essential Details Sought (EDS) for Forest Clearance (FC) application of Loc.MKD on 15.07.2017.

Reference to your EDS query against our Forest Clearance application for LOC: MKD, please find below our comments.

- A. EDS Query: C (ii) (a): No action has been taken for uploading the patch wise KML files against the Proposed diversion area as E-communicated vide our observation dated 08/06/2017. So patch wise KML files may be uploaded and arrange to send a copy of the same to our E-mail address addlpccf.nodal@gmail.com.
 - <u>OIL's View</u>: C (ii) (a): The KML files showing plinth area and approach road area in patch wise, has been uploaded in the online form and the same has been sent to your email address mentioned in your EDS. (Copy enclosed)
- **B. EDS Query: C-(iii)**: Despite specific request vide our E-communication dated 08/06/2017 to rectify the 1:50,000 scale SOI toposheet map as depicted only the Plinth area and Geo-coordinates readings, no action has been taken against the column no C-(iii). So please take necessary action for onward processing of the proposal
 - <u>OIL's View:</u> C-(iii): The full size Toposheet map in 1:50,000 scale showing all the mandatory components, legends and DGPS/Total Station coordinates points has been uploaded in the online form and the same has been sent to your e-mail address mentioned in your EDS. (Copy enclosed as **Annexure I**)
- **C. EDS Query**: **C-(iv)**: The uploaded item is a copy of 1:50,000 scale SOI toposheet map depicting the Plinth area and its Geo-coordinates

readings instead of required geo-reference map of the proposed forest land to be diverted for non-forestry purpose. Further, the approaching road connecting to the plinth area mentioned in the column no B-2.4 (2) has not been depicted. Hence, afresh map showing the area to be diverted in a geo- referenced map in shape file, showing the diversion activities distinctly on the map along with mandatory components, appropriate legends, DGPS/Total Station coordinate points and DGPS/total Station coordinate readings should be reflected in the map and uploaded.

<u>OIL's View:</u> C-(iv): The Geo-reference showing the diversion activities distinctly on the map along with mandatory components, appropriate legends, DGPS/Total Station coordinate points and DGPS/total Station coordinate with the approaching road connecting to the plinth area mentioned in the column no B-2.4 (2) is enclosed as **Annexure-II**.

We have uploaded the Pdf format in the online application since there is no provision in the online form to upload the shape files. However, we have sent the same in your email for your necessary concurrence.

- **D. EDS Query: K- (i):** The process for settlement of Rights under the Forest Right Acts 2006 on the forest land proposed to be diverted should be Yes instead of No comment furnished by you. So rectify the same.
 - <u>OIL's View:</u> The necessary correction has been made in the online form.
- **E. EDS Query**: **M-1-(i)-(b)** & **M-2-(i)**: The '**date**' reflected under the column no M-1-(i)-(b)- does not match with date of grant of Petroleum Mining Lease by Govt. of India, Ministry of Petroleum & Natural Gas. So kindly clarify the same.
 - OIL's View: M-1-(i)-(b): The correction has been made in the online form. However, the online application form asks for date of approval of LOI & Mining Plan which are not applicable to OIL since PML has been granted to OIL under PNGR 1959 which does not require LOI and Mining Plan. Therefore, to fill the online form the date of grant of PML by State Mines & Geology Department has been mentioned as 16.06.2008 for Mechaki PML of OIL.

A copy of PML grant letter by MoPNG and State Mines & Geology Department is uploaded in additional information column.

F. EDS Query: M-2-(vii): No action has been taken for uploading the KML file of the outer boundary of mining lease area against the

proposed diversion area as E-communicated vide our observation dated08/06/2017. So the KML files may be upload and arrange to send a copy of the same to our Email address addlpccf.nodal@gmail.com.

<u>OIL's View</u>: M-2-(vii): The KML file of outer boundary of mining lease has been uploaded in the online portal and the same has been sent to your email address. (Copy enclosed)
