**Subject:** Clarification for not taking Permission for Diversion of Forest Land prior to Construction of Retail outlet.

Sir,

Kindly refer to Our proposal for Diversion of Forest Land for our Retail Outlet at Khasra No. 898 (old 734/2). SH-60 (Old SH-18 ), Village- Bherunda, Tehsil- Degana, Distt.-Nagaur.

In this regard we wish to submit that our RO was commissioned in year 1999 and at that time, no such provision for Diversion of Forest Land existed. We have commissioned the outlet after taking necessary approvals & NOC form District Magistrate, Nagaur. At the time of Commissioning, we did not receive any directions from any department for Diversion of Forest Land for Approach Road.

Further, Vide letter dated 24.05.2016, it has now been advised by Dy. Conservator of Forest, Nagaur to apply for Diversion of Forest land as per guidelines issued on 15.07.2004.
