Sub: Retail Outlet proposal at Rewari on Rewari-Barnaul

We refer to your application dated 29.3.76 regarding the proposal for putting up a retail outlet at the above location.

We now write to record the terms and conditions on which we are prepared to consider installing M/S/BSD pump at your side at Rewari.

- 1) You will arrange at your own cost for the filling, levelling of the site, provision of culverts, construction of block, electrification of the outlet (this includes electricity service connection to your meter board as well as drawing wires to the pump) fencing around the licensed premises and provision of water facilities.
- 2) We shall provide and arrange for the installation of a pump and tank ~~cost~~ for M/S/BSD.
- 3) You will have to deposit with us a sum of Rs. 25,000/- as security deposit which will be retained by us on the terms contained in our form of standard agreement for dealer developed site. A specimen of our said form is enclosed for your perusal. The current rate of interest payable on the security deposit is 7% per annum which will be payable only on Rs. 25,000/-.
- 4) We shall appoint you as our dealers to operate the outlet on our standard terms as per above mentioned form. You will have to sign an Agreement on these terms.
- 5) This agreement can be terminated by either party without notice at any time before construction of the pump is taken in hand.

4) Except with the previous written consent of the Corporation:

a. We shall not enter into an arrangement, contract or understanding whereby our operations hereunder are or may be controlled, carried out and/or financed by any other person, firm or company whether directly or indirectly and whether in whole or in part.

b. We shall not effect any change in our constitution whether in the identity of our partners/members or in the share/shareholding of any of them or in the terms of the Deed of Partnership or of bye law or the case may be.

In the event of the death of any partner/member of firm co-operative society appointed hereunder, the surviving partners/members will agree to indemnify the company against any claims or demands which may be made by the heirs of the deceased partner/member.

7) We shall recover from you by way of License Fee Recovery an amount of Rs.10/- p.m. which is subject to Revision at the discretion of the Corporation.

Kindly sign and return to us the enclosed copy of this letter in token of your acceptance of the above terms and conditions in enable us to take the work of installing tanks and pumps in hand urgently.
