1. Project details:-

(i) Short narrative of the proposal and project/scheme for which the forest land is required:

The scheme is for construction of **LILO OF ONE CIRCUIT OF 220 KV D/C TTPS -GOVINDPUR TRANSMISSION LINE AT GSS JAINAMORE**. The proposed Transmission Line shall connect the 220 KV Grid sub-station Jainamore in Bokaro District of Jharkhand. The line traverses through BOKARO (district of Jharkhand). The line shall transfer the power from TVNL to 220 KV grid Substation Jainamore. Some portion of the line is passing through the forest land of Bokaro forest division where a corridor of 35 m shall be utilized for construction of the said line, as well as maintaining statutory electrical clearances for safe operation.

(ii) Maps Shows the required Forest Land, boundary of adjoining forest on 1:50,000 scale map: Enclosed as Annexure-XV.

(iii) Cost of the project: Rs.24.031 crore, (Approx.). Details of alternatives alignment examined for the transmission line enclosed at Annexure-VII.

(iv) Justification for locating the project in forest area:

Efforts have been made to avoid the forest from the transmission line corridor, but due to spreading forest from east to west between the terminating points of the transmission line, we cannot avoid the forest fully from the corridor. However to minimize forest area, the line has not been taken as straight, rather it has been taken away from the "BEE LINE" (the straight line joining the terminating points of the transmission line) Map showing the spreading of forest on 1:50,000 scale SOI map is enclosed at Annexure-III.


