- After detailed study of alternative Layouts for proposed Upper Indravati
 Pump Storage Project (UIPSP), the present Layout has been selected and finalized basing on the factors maximum output, cost effective etc.
- The said layout was approved by Water Resource Department, Govt. of Odisha vide letter No-16393 dated 29.7.2015 and allowed OHPC to prepare DPR.
- The draft DPR has been prepared and submitted by WAPCOS Limited (The consultant hired by OHPC for Preparation of DPR of UIPSP) and the layout of UIPSP has been finalized in consultation with Central Electricity Authority (CEA), Central Water Commission (CWC) and Geological Survey of India (GSI) of Govt of India.
- As per the norms now there is requirement of excavation of investigation tunnel to test the rock and soil quality along the axis of the Power House for construction of Underground Power house in future after approval of the DPR.
- The location of drift and site of disposal of excavated muck is chosen as per the layout plan, suitability for power intake from existing Upper Reservoir of Upper Indravati Hydro Electric Project, Proposed site for lower reservoir, site of new Power House and as per the site visit of Geological Survey of India (GSI) officials.
- The location of drift site cannot be altered as the layout of the Proposed UIPSP has been finalized and the upper reservoir of UIHEP already exists
