- 1. With reference to our proposal vide reference (1) cited above, we have requested for diversion of 3.256 Ha Forest Land. But as per the clearance norms of TAMILNADU TRASNMISSION CORPORATION & as per the Government of India guideline F.No.7-25/2012-FC dated 05.05.2014, the area has been revised as 0.930 km x 46 meters width =4.278 Ha. Accordingly we have been requested to make changes online at our end vide reference (2) cited.

- (II) In this regard, a mail has been sent to monitoring—fc@nic.in on U3.U9.2U18. It has been replied on 08.09.2018, to furnish the contact details and will call you back and solve and problem. On 18.09.2018 & 03.10.2018 the contact details were furnished. But nobody has not yet contacted till date. (Copy of mail enclosed)
- (iii) Under the circumstances, it is submitted that, we hereby undertake to accept the revised area of forest land required as 4.278 Ha (instead of 3.256 Ha applied through online portal vide proposal No:FP/TN/TRANS/15163/2015) in Solanur Reserve Forest. For this purpose, a revised under taking is also enclosed herewith.
- (iv) Further to the above, it is also assured that the TAN TRANSCO will ready to pay the amount for compensation afforestation worked out to the revised area of forest land required to an extent of 4.278 Ha (instead of 3.256 Ha) "
- 3. In this regard the following is submitted that , though the Area in on line portal of User agency (Part I) is unable to modify, the particulars like (i) undertakings, (ii) Certificates, (iii) All correspondences and (iv) NOC from District Collector etc., have been obtained and submitted considering the revised area of 4.278 Ha only.

Under this circumstance, it is humbly requested that the necessary arrangement for editing and revise the A-1 (viii) section in Part-I may kindly be arranged to modify through your channel and process our proposal at the earliest by considering the importance of this scheme in the interest of General Public.




