Undertaking.

M/s Reliance Jio Infocomm Limited have applied for diversion of forest area for laying of Optical Fibre Cable along the National Highways – State Highways road.

In Government of India guidelines of Forest (Conservation) Act, 1980 in F. No. 5-3/2007-FC, dated 05.02.2009, payment of Net Present Value for underground laying of Optical Fibre Cable has been allowed, if the area does not form a National Park / Sanctuary and no felling of trees is involve.

The Above area is not declared as National Park / Sanctuary. For the execution of the above work, felling of trees of any nature (planted / spontaneous) will not be done and alignment will be carried out to avoid removal of trees in the alignment path. Hence Net Present Value is not payable in the present case.

However, if subsequently any clarification / order is issued by the Central Government / Hon'ble Supreme Court of India to the contrary, we undertake to made such payment on issue of a demand note by the State Forest Department / competent authority.

Detailed note on the Project.

The Optical Fibre Cables are always laid along the road side due to easy supervision, quick maintenance and low cost of maintenance. The applicant does not have to acquire land for this project purpose, as the road side land is under the control of State Highways / National Highways Authority of India. However the land classification is forest land.

The cable shall be laid on 0.45 metres width of surface land & up to 1-2 metres depth and nearer to the extreme road boundary where alignment of trench will be done in such a way that, no trees will required to be cut.
