Adverting to the reference cited above, it is submitted that vide reference 1st cited the Prl. Chief Conservator of Forests, TS, Hyderabad has forwarded the proposals in Form-A for diversion of forest land to an extent of **409.53 Ha (387.13 Ha Horizontal area as per DGPS) in Medchal forest Division** under Medchal District – for construction of 10 TMC reservoir at **Keshavapuram** with associated components under Godavari river source for drinking water requirements to the Hyderabad City in favour of HMWSSB and requested to process under Forest Conservation Act, 1980 and guidelines/ rules issued there under.

Accordingly the processed proposals are submitted vide this office reference 4th cited and the proposals are also submitted to Government vide reference 6th cited above.

Further it is submitted that during the visit to Kandlakoya Oxygen Park on 25.07.2020, the PCCF TS Hyd has issued instructions to prepare Wildlife Mitigation Plan in Ponnal and Yadgarpally-I & II RFs to accommodate the wild life in the proposed area for diversion which will migrate to these adjoining forest blocks, if the Keshavapur RF is diverted. Accordingly the proposals are prepared with an outlay of Rs.266.87 Lakhs and submitted herewith for inclusion in the project.
