

Brief Background-Dongia Nalla (3.79 hectare) of Forest Lease Land

1. 3.79hectare forest land (Dongia Nalla) lease land given by the Forest Department to M/s. Kanoria Chemicals & Ind. Ltd., Renukoot for the period of 25 years i.e 01/04/88 to 31/03/2013 for the purpose of installation of Pump House, Pipe Line and Over Head Transmission.
2. On 16/04/2011 after discussion between M/s. Kanoria Chemicals & Ind. Ltd., Renukoot and M/s. Aditya Birla Chemicals (India) Ltd., Renukoot it was resolved that the assets pertaining to M/s. Kanoria Chemicals & Ind. Ltd., Renukoot to be transferred to M/s. Aditya Birla Chemicals (India) Ltd., Renukoot.
3. In pursuance of resolution passed, M/s. Kanoria Chemicals & Ind. Ltd., Renukoot given its NOC for the transfer of land in and against this NOC, M/s. Aditya Birla Chemicals (India) Ltd., Renukoot given its consent letter and agreed to obey the conditions which are imposed by the government and which may be imposed by the Central/State Govt. in future for the transfer of lease land in the name of M/s. Aditya Birla Chemicals (India) Ltd., Renukoot.
4. Application was submitted before DFO Renukoot, for transfer of lease along with undertaking and Consent/NOC of M/s. Aditya Birla Chemicals (India) Ltd., Renukoot and M/s. Kanoria Chemicals & Ind. Ltd., Renukoot respectively for the transfer of lease as prescribed under chapter 2 Clause 2.8 (Transfer of Lease) Forest Conservation Act. 1980 Guideline and Clarifications.

5. On 30/03/2012 renewal of lease proposal was submitted before DFO Renukoot one year prior to the expiry of the lease period.
6. M/s. Aditya Birla Chemicals (India) Ltd., Renukoot has been amalgamation Grasim Industries Ltd., Renukoot in accordance with order of the Hon'ble High Court, Jharkhand, Ranchi dt. 24/11/2015. M/s Aditya Birla Chemicals (India) Ltd., Renukoot. and Grasim Industries Ltd., Renukoot both belong to M/s. Aditya Birla Chemicals (India) Ltd., Renukoot and the business of M/s Aditya Birla Chemicals (India) Ltd., Renukoot has been transferred ongoing concerned and as is where is basis to Grasim Industries Ltd., Renukoot due to amalgamation. The information of the event was already informed to DFO, Renukoot by the letter dt. 14/01/2016.
7. By the letter dt. 14/1/16 it was informed by DFO, Renukoot to M/s. Aditya Birla Chemicals (India) Ltd., Renukoot for submitting fresh lease renewal proposal in the name of Grasim Industries Ltd., Renukoot and also informed that earlier proposal for lease should be considered cancelled.
8. Grasim Industries Ltd., Renukoot deposited lease rent of forest land and further also deposited premium and lease rent with interest in view of the direction issued by the land DFO, Renukoot.
9. As per the advise of DFO Renukoot for submitting fresh proposal for the renewal of lease of forest land we again submitted the fresh proposal for the renewal of lease in the year 2016.
