Sub: Forest Diversion Proposal over 11.959 Ha. forest area coming under the proposed mining lease area of Parasi Gold Block, in District Ranchi.

Further to our letter no. RML/BD/Parasi/18-19/499 dated 18.02.2019 submitted in reply to your letter no. 213 dated 21.01.2019 giving therewith point wise compliance status as raised in your referred letter.

Subsequently, we received letter no. 1705 dated 19.06.2019 asking for submission of No Objection Certificate(NOC) required for Forest Clearance of "Jangal- Jhari category" of Forest land over 18.66 Acre(7.55 ha.) land falling within the 11.959 Hectare forest land applied for Forest Clearance under our proposal no. FP/JH/MIN/37423/2018 dated 03.12.2018.

In the matter, we are submitting herewith a copy of No Objection Certificate(NOC) issued by the Dy. Commissioner, Ranchi District vide letter no. 1878 (ii) S.S. x-11/2019 dated 31.07.2019 over 16.55 Acre(6.74 ha) and an affidavit giving No objection with respect to Khata No. 247, Plot no. 1307(P) having an area of 2.01 Acre(0.81 Ha) by its Raiyat(Land Lord) Hari Singh Munda(sole surviving inheritor of Late Kishun Rai) in village Parasi, Thana No. 151 of Bundu Anchal, Ranchi District. Thus, the required NOC over $16.55 + 2.01 = 18.56$ Acre (i.e. $6.74 + 0.81 = 7.55$ Hectare) is furnished herewith. Copy of NOC issued by the Dy. Commissioner, Ranchi District vide letter dated 31.07.2019 is enclosed as **Annexure-1A** and copy of affidavit giving NOC of Hari Singh Munda(sole surviving inheritor of Late Kishun Rai) is enclosed as **Annexure-1B**.

Sir, further to our letter no. letter no. RML/BD/Parasi/18-19/499 dated 18.02.2019, we are submitting herewith point wise compliance status summarised as under:

		In this context, we would like to seek your kind consideration of the provisions of the Circular issued by Ministry of Environment, Forest and Climate Change, Government of India vide File No. 11-43/2013-FC dated 26.02.2019 through which it has been clarified that FRA certificate is not required for consideration of in-principle approval (i.e. at stage-I). This has to be furnished by the State Govt. for consideration of proposal by the MoEF & CC for final approval (i.e. at stage-II) level. Copy of Circular vide File No. 11-43/2013-FC dated 26.02.2019 is enclosed as Anexure-2B.
2.	List of Tree enumeration coming under the proposed forest area for diversion is not attached.	List of Tree enumeration of area applied for FC duly certified by Range Officer, Bundu is already submitted vide the Range Officer's letter no. 105 dated 14.05.2019.
3.	Environmental Clearance letter not attached.	(i) We have applied on 24.12.2018 to the State Level Environment Impact Assessment Authority (SEIAA), Ranchi, Jharkhand for the grant of TOR for EIA studies & preparation of EIA& EMP Report required for processing of application for the grant of Environment Clearance (EC). Copy of our application dated 24.12.2018 is enclosed as Anexure-3A. (ii) SEIAA has accorded Terms of reference (TOR) vide Letter No. EC/SEIAA/2018-19/2095/2018/153, dated 05-04-2019 (copy enclosed as Anexure-3B). (iii) Draft EIA & EMP report is prepared & submitted to Jharkhand State Pollution Control Board (JSPCB), Ranchi for Conducting Public Hearing required in the process of Grant of EC vide our letter no. RML/ BD/ Parasi/ 19-20/120 dated 08.07.2019(copy enclosed as Anexure-3C). (iv) Jharkhand State Pollution Control Board(JSPCB) has already notified date of conducting Public Hearing on 22.08.2019. Copy of Notification of conducting Public Hearing dated is enclosed as Anexure-3D.

Separate land Schedule for Notified Forest land and Jungle-Jhari category of Forest land along with a Map showing separately the said two types of Forest Land on Cadastral Map is submitted to your kind office vide our letter no. letter no. RML/BD/Parasi/18-19/499 dated 18.02.2019, copy of the same is enclosed as Annexure-5 .

In view of the above submissions, we humbly request to please process our application for the grant of Forest Clearance under Section 2(ii) of Forest Conservation Act, 1980 submitted vide our proposal no. FP/JH/MIN/37423/2018 dated 03.12.2018 and forward the same with your kind recommendations.
