- (ii) Copy of Nishandeli done by Sh. Dilbag Singh, Forest Deptt
for land 4 Biswa over which the small house over
1.22 Biswa has been constructed.
- (iii) Copy of Nishandeli done by the Revenue Deptt (Tahsil)
Morni of land 4 Biswa
- (iv) Copy of Nishandeli done jointly by the Tahsildar and
Forest Deptt for complete Khana No. 461 of land area
5 Bgza and 12 Biswa
- (v) Purchase of Girdawari rights of total land 5 Bgza, 12
Biswa from Sh. Jeet Singh on dated 15/5/2018 (copy attached)
- (vi) Plantation: 100 Deodar plants were planted in
the month of July 2019 after purchasing from Forest Deptt
(HP) (copy of bill attached)
50 Plants of Nimbu (Lemon) were planted after
purchasing from Gout Nursery, Panchkula (copy of bill attached)
- (vii) Rough sketch of the land 17 Biswa showing constructed
small house over 1.22 Biswa (61 sq yards)

and to nurse them besides getting closer to the
Nature.

In the past 10 years, the said segment of land (plantation) over Ichana No. 461 has to face hazard of jungle fire in the summer due to shedding of inflammable pine needles. Due to bushes under the pine trees, no one takes away fallen pine-needles because it is not possible to comb needles from the bushes. After getting Nislandeli, we comb & sweep pine needles resulting to prevent chances of fire.

Without presence of owner (or his person) of land, no long stretch of pine trees can be saved from summer fire. Due to the said reason in this summer (June 2021) pine trees in Baley (moem) got fire due to short circuit of electric wires. It was prevented from spreading fire to next hill by the ~~owner~~ owner and his men of a Hotel, who has hotel there.

Part-C

In this Modern world, Forest Department still expect that owner of the land or even the farmer should have a hut covered with ~~stanchi~~ / ~~chiti~~ to nurse and to protect the plants.

Now in this Modern world it is not possible to stay in such conditions due to mosquitoes and other insects. Entry to hut of snakes can't be prevented. ~~In~~ In the past during British rule, money reward was given to whom, who kill the snake whereas now snakes are being protected, resulting to increase in their population.

Further, for call of the nature, person has to go in the open, whereas now under Pradhan Mantri Yojna no one is allowed to do so in the open, one must have a toilet in his house.

Part-D

No such action by the Forest Deptt has been taken over the construction of the Hotels and Guest Houses which have been constructed along the Thapli-Mam Road. Moreover action taken by the country and

Town Planning Deptt has been dropped. Then why such action is being initiated over construction of a small house to be used as care for the plantation.

I am the plant and Nature lover i.e., why

I desired to be here, otherwise much cheaper land at best location are available to construct bigger house.

~~For~~ For your kind reference I planted some Chirk (Pine) plants in the year 1984 in front of my house at Panchkula and also in front of my factory at Chandigarh. Still 5 Pine trees at each place exist by attaining height not lower than 40 feet. They all are much healthier than Chirk plants in Morni due to the fact they are being well nursed.

Some Pine trees are in my farm house at Bura Kotian which were planted in the year 2000 and they too are healthier.
