- Name: 136-Bhogpur-Kotla.Compartment-1
- Situation: Situated to East of Sunkri-Nadi and West-South of village Kotla.
- Boundries:
 - N:- Kotla-Ka-Khala and Khali which joins Sunkri also separating compartment-2.
 - E:- Kotla-Ka-Khala, Zamindari Forest private Cultivation of village Mirpur & Kotla.
 - S:- Interstate Boundary of Haryana.
 - W:- Sunkri-Nadi and Zamindari Forest Land/Cultivation of Churan of Tede-Gumti.
- Configuration :- Terrain hilly broken by local Khalas and ridges.
- Locality Factors :-
 - a Altitude :
 - b Aspect : South-East and slightly Western.
 - c Slope: Gentle to steep.
 - d Soil & Sub-soil : Clayey and clayey-lean with typical Shiwalik boulders present.
 - e Drainage : Satisfactory.
 - f Erosion : Moderate.Heavy above village Majri and adjoining C.2 and on lower portion touching Gumti.
- General composition :-

It is essentially a dry deciduous mixed scrub with open to very open eroded portions in between and along the Khala. The entire area has been planted in the past with Khair, Shisham and bamboo. However the Khair crop has come up mainly towards the South Western end of the compartment, near the Majri check post. This crop is reasonably dense and has reached almost pole stage. There is a small patch of middle to mature Eucalyptus near Kotla village. Rest of the area is eroded and almost blank with rare Chhal, Jhingan, Shisham seen scattered here and there.

- a Principal Spp. : Khair, Euclyptus, Shisham etc.
i Age class : Young to middle.
ii Quality : --
iii Stocking : Moderate to open.
b Under wood : Rare.
c Under growth : None-being grassy blank except sparsely scattered spp. like Karenda, Kuri, Bhai, Dedenea, Neur, Lantana & Gandhella, Basuti etc.

e Ground cover : Grasses Dhelu, Bhabhar and Sarala etc.
f Re-generation : Exists in the form of planted Khair poles towards the South-Western portion of the compartment.

10 Right & concessions : As per faisla-e-Janglat.

Failed portion be taken^{up} for plantation afresh. Soil conservation measures are also required here.
