

**BRIEF NOTE ON FORMATION OF ROAD FROM VADAMAMIDI TO CHINA  
AGRAHARAM OF G.K.VEEDHI MANDAL IN VISAKHAPATNAM DISTRICT**

The road work "Formation of Road from Vadamamidi to China Agraharam has been approved by Ministry of Rural development under PMGSY I (Police Blocks ) for Rs. 210.73 Lakhs. The existing surface is earthen road .The road serves the total population of 556 (Peda Agraharam & China Agraharam) . As there is no proper transportation facilities the school going children are becoming agriculture labour. The basic occupation of the people in this area is agriculture and agriculture is totally rain fed. The main food crops are Paddy, Ragi, Pepper, Cabbage, Carrot, Ginger etc., The crop yielding is generally very good and needs to be transported to the nearest marketing center and weekly sandies so as the formers get better benefits and true value.


