Additional Information for the proposed area -

As per the Working Plan of Jalpaiguri Division for the period 2007-08 to 2016-17, which was approved by the MoEF, Government of India vide no 13/FCWP/WB-JP dt 14.03.2008, the proposed area is within the limit of the area whose management is under Public Works Department and was allowed for setting and maintenance of communication line. In the Volume I of this plan the Chapter 1.10 says about the reserved forest under other Department or Directorates and regarding management it says, "all timber and the forest produce on the land are the property of the Forest Department. Other Departments or Directorates have the right of use only."
