| Back Ground: | At present there is one 33/11KV S/Stn. At Vill-Goaltore under the said Police Station. This block is getting power through 5 nos. feeders of total route length of 11KV-55 Kms. & 33KV 25 Kms. which have been emanated from Goaltore 33/11KV S/Stn. which is overloaded. Since few areas which is not sufficient for feeding uninterrupted power supply to the North end of Goaltore Block. The area is non-agriculture one and approx. 500 private Agricultural consumers demanding smooth power supply in all season for vegetable production. Beside that there are approx. 7,000 nos. Dom, 500 nos. Comm. & 3 Ind. consumers, 3 nos. bulk premises exists. |
| Purpose : | Since there is only one 33/11KV S/Stn. under Goaltore Block and where present growth of agricultural connections is considerable under Hoomgarh Gram Panchayet situated at the North end of Goaltore Block at a distance of approx. 10 Km. from the existing S/Stn. and also 100% village electrification work is almost completed. Presently it has been assessed for 2x6.3 MVA demand from the proposed S/Stn. which is very much essential to meet up the growing demand and to provide better quality power supply with minimum requirement of voltage and to minimize loss of energy through supply of power with less H.T. Line. |
| Socio-economic benefit: | National & State interest will be served through supply of power specially to the agricultural consumers along with others consumers and to dispose of the pending connections under Amlagora CCC. |
| Job Creation: | For construction of aforesaid S/Stn. new industries may be constructed in the locality which will create a good nos. of employment opportunities. Besides, that pending agricultural connections will be liquidated that may be energized agricultural pumps for their cultivation specially in the Jungal Mahal area. |
| Construction activities : | 2 nos. of Power Transformer would be installed at the capacity of 2x6.3MVA with drawal of 33KV Line-32 Km & 11KV Line-30 Km. |
