lands near Karakambadi of Renigunta Mandal-proposed for Sri Balaji Reservoir and Mallemadugu Reservoir & Kailasagiri Canal under GNSS Project- Compensatory afforestation lands identified in Peddamandyam, Gurramkonda & Nimmanapalli Mandals-advance possession to the Forest Department- orders-issued.

ORDER:

In the reference 1st read above, the Chief Engineer, Water Resources Department , NTR TGP Unit, Tirupati has reported that, forest lands measuring 473.00 Ha. are required for the bund portion and for foreshore Sri Balaji Reservoir, for the foreshore area of Mallemadugu Reservoir is about 120.00 Ha and for Kailasagiri canal which is part of Mallemadugu Reservoir is about 152.50 Ha, total forest land required for the projects is 745.50 Ha (746.00 Ha). The Chief Engineer has requested to allot 745.50 Ha. of land under compensatory afforestation for completion of Sri Balaji Reservoir and Mallemadugu Reservoir and for its canals near Karakambadi village of Renigunta mandal.

In the proceedings 2nd read above, Divisional Forest Officer, West Division, Chittoor and the Sub Collector, Madanapalle were addressed to conduct joint inspection for identification of government lands and to send suitability report for providing lands under compensatory afforestation.

In the reference 3rd read above, joint inspection report was received from the Joint Collector, Chittoor the Divisional Forest Officer, Chittoor West Division, Chittoor and the Superintendent Engineer, GNSS Circle, Tirupati stating that, the following government lands/assigned lands in Gurramkonda, Peddamandyam and Nimmanapalli Mandals were found suitable for compensatory afforestation.

In the reference 4th read above, a report was sent to the Special Chief Secretary to Govt., Revenue Department stating that, the total extent of 991.88 Hectares may be transferred to Forest department in lieu of 745.50 Hectares of forest land in Karakambadi area; that joint inspection was carried by the Joint Collector, Chittoor, Divisional Forest Officer, west Division, Chittoor, Revenue Divisional Officer, Madanapalli, Superintending Engineer, GNSS, Tirupati Spl Deputy Collector, GNSS, Tirupati on 26.06.2018 and the committee came to the conclusion that, out of 991.88 Hectares, 745.50 Hectares only is found suitable for compensatory afforestation and the remaining land 246.38 is unsuitable for any vegetation activity; that the additional lands given to forest department is mountaneous area with rocks and boulders, not suitable for any future purpose; that the estimation of suitability is only ocular in nature and the unsuitable land is sparsely distributed in between the suitable land and cannot be subdivided, to protect and conserve the forest, it is justifiable to transfer entire 991.88 hectares to Forest Department.

In the G.O 5th read above, the Government have issued orders according permission to hand over advance possession of the following lands to an extent of 991.81 Ha. in Chittoor District to Forest department in lieu of 745.5 Ha. Of forest lands to be taken for construction of Sri Balaji Mallemadugu Reservoir and Kailasagiri canal under GNSS Project.
