
With reference to the above subject, I submit that the details sought by the District Forest Officer, Madurai vide reference (7) cited, as follows:

- (i) Revised Form A, Part I proposal has been uploaded for revised area for 0.0332 ha. in Doddappanaickanur North R.F.
- (ii) An application submitted to District Collector, Madurai for obtaining revised FRA certificate and will be uploaded in portal.
- (iii) The following points are ensured that
 - (a) I am informing that no trees or vegetation will be felled or disturbed during the execution of the project.
 - (b) I am informing that an earth mover will be used without disturbing the vegetation and the excavated earth will be dumped on road side only not in forest side.
 - (c) I am informing that the excavation will be immediately closed after laying the pipeline without affecting the migrating animals.

And also, I wish to state that the modification facility of **total area of the project** under the head of **A.1. Project details** is not available. Hence, we upload the revised SI Sheet Map, Google Map and .kml for the revised area without editing the total area in project details.
