xi.	Layout Plan of the proposed area to be submitted.	
xii.	Status report to be uploaded against the guideline of GoI, MoEF & CC, New Delhi vide F.No.8-118/2006-FC/ dated 24.06.2015 towards making of payment of 2% of NPV of total forest area within PML area.	
xiii.	Project wise mouja map to be submitted with proper demarcation with showing legends and signature of the user agency.
