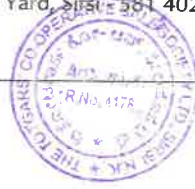

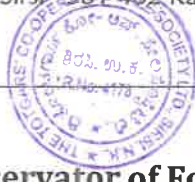

Sub : Change of land use pattern of 2.02 hectare of forest land in Chipagi village Survey No. 47, Sirsi Taluka, Uttara Kannada District (Sirsi Forest Division) diverted under Forest (Conservation) Act 1980, originally for construction of 100 bed Modern Hospital to now proposed for various purposes like construction of Areca Auction House, Areca Research Centre, Ware House along with Ayurvedic Hospital, Ayurvedic Research Centre and allied purpose in favour of the Totgars' Co-operative Sale Society Limited Sirsi.

With respect to above mentioned subject matter we had submitted proposal for diversion of 2.02 hectors of forest land at Sy.NO.47 of Chipgi Village in Sirsi Taluk, North Canara District, Karnataka State for the purpose of construction of 100 bedded multi specialty hospital in 1998-99. Our proposal was approved after the lapse of very long period of 18 years and Stage II approval was accorded in 2016. And it took another two years to get the land handed over to us. Finally, the land was handed over to us in 2018.

During the course of 20 years a multi Specialty hospital has been established at Sirsi. So, our Management thought that rather than duplicating the service the public are already having, we could set up an Ayurvedic Hospital as an additional service in the diverted land. Also, Our Western Ghats region is rich in herbal medicines which can put to best use by establishing an Ayurvedic Research Centre to help general public by researching new medicine for various diseases and same output shall be provided to the Government. Also, as the main objective of our society is to safeguard the welfare of areca nut farmers of this

region, we have planned to establish an Areca nut research Centre to study and propagate the medicinal uses of Areca nut in the diverted land which will be an allied activity of Ayurvedic Research. This is also of vital importance from the point of view of our farmer members to provide scientific data to prove that Areca nut is not injurious to human life, instead it is useful medicinally.

So our management has decided to use a portion of the already diverted forest land in F.Sy. No. 47 of Chipagi village in Sirsi taluk for carrying out some of the activities like Ayurvedic Research, areca nut auction, areca nut research, storage etc. after allocating sufficient land for the construction of hospital by making suitable changes in the approved lay out plan. Accordingly our management has changed the plan of establishing allopathic hospital to multipurpose project involving construction of Ayurvedic Research Centre, Areca nut Research Centre, Areca nut Auction House, Warehouse, etc. along with the construction of Ayurvedic hospital.

We have examined alternatives for our expansion purposes. But, there is no space left in A.P.M.C. yard where we are presently operating. And also as our district comes under Western Ghats region, majority of our district is covered by forest land. We could not find suitable revenue land available in the area for the purpose of our expansion. In this regard we are attaching the certificate from the DC, Uttara Kannada district. Still, we have examined other possible alternative non-forest lands for the purpose of our expansion purpose. But the alternative places we have examined turned out to be unsuitable due to remoteness, steep terrain, no easy accessibility etc.

Accordingly we have submitted above referred proposal for change of land use pattern. During various stages of the processing of our proposal, as per the instruction from the Department, we have submitted justifying note and undertaking letters explaining the alternatives examined and reasons for

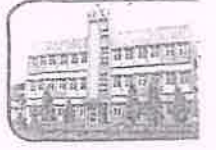

We have examined three alternatives for our expansion purposes. One at A.P.M.C. Yard, Sirsi as this is the prime location for our expansion activities. If we could get the land for expansion here, it would have been very suitable for us because our existing operations are located at A.P.M.C. yard only. But, unfortunately there is no land left in Sirsi A.P.M.C. yard, and we have to reject this option. In this regard we are attaching the map of Sirsi APMC Yard and the location of the Yard is marked as Alternative-1, APMC Yard, Sirsi in the map.

We have examined other possible alternative non-forest lands for the expansion purpose. The second one was at Isaluru village of Sirsi Taluk. But this alternative place was rejected after we found out that there is a litigation going on regarding the land and titles of the property are not clear. So we rejected this option too. In this regard we are attaching the map of Sirsi APMC Yard and the location of the Yard is marked as Alternative-2, Isloor Sy.No.124 in the map.

We again examined another alternative at Sy.No.45 in Hosakoppa village of MundgodTaluk. This place is more than 20 KM from Sirsi, and it would be practically not feasible to shift the project that far away. So we have to reject this alternative and in this regard we are attaching the map of Sirsi APMC Yard and the location of the Yard is marked as Alternative-2, Isloor Sy.No.124 in the map.

After examining the above three alternatives and after they stood rejected due to above explained reasons, our management has decided to use a portion of the diverted forest land in F.Sy. No. 47 of Chipagi village in Sirsitaluk for carrying out some of the activities of our society like areca nut auction, running the rice mill, areca nut research, storage etc. after allocating sufficient land for the construction of hospital by making suitable changes in the approved lay out plan. As our proposal for diversion of Forest land got approved after a very long period of 18 years in 2016 and the handing over process took another two years and we got possession of the diverted forest land in 2018, naturally during the lapse of this long duration the requirements of our Society have changed with changing demand of our members.
