In this connection, it is intimated that the reply of the para no.2 of the letter under reference is given as under:-

1. Forest Case No. FP/HR/Road/1881/2011 was applied for deforestation for the widening of Bhiwani – Jind road. But in the year 2015 the road was transferred to NH Bhiwani and after that the road was transferred to NHAI Rohtak. Therefore, the case of diversion of forest land of the above mentioned road is not required by state PWD Department. (Copy attached)(Annexure 'A') .
2. Forest Case No.FP/HR/Road/7808/2014 was applied for deforestation for the widening of Bhiwani –Loharu road by NH Rohtak. In this matter it is intimated that the case of deforestation has already been approved from Forest authority (Copy attached) (Annexure 'B').

3. Also, the Forest Case No. FP/HR/Road/537/2006 does not exist. Hence it is requested that this case may please be filed.

The Compliance of the observations on the letter under reference has already been done.
