**Kindly refer to your office letter No. 2388/FCA dated 08.12.2022 on the subject cited above.**

It is informed that the university submitted the case to your office alongwith required documents through online. The point wise reply of observations is as under:-

- I. The Topo sheet/survey sheet has already been attached with online application & the same has also been enclosed with the manual file.
- II. **Point no. 4** – Joint inspection report duly signed by Registrar and your goodself has also been submitted to your office which is to be filled up by your office or as per record.
- III. **Point no. 5** – The NOC of Pollution Control Board is not required in this case because more than 4000 plants have been planted by the Forest Deptt. Narwana in the campus of Regional Centre Kharal (Jind). Further two employees were deputed by the Forest Department to look after the plants. Only 45 to 50 eucalyptus trees are to be removed from the site to construct the approach road.

However, the new academic session for admission is to be started very soon and the construction of approach road is urgently required before starting the said session. It is pertinent to mention here that the classes of new session is to be started in newly constructed building of Regional Centre Kharal and the

inauguration of the said building will be done by Hon'ble Chief Minister/Deputy Chief Minister, Haryana but due to non-removal of eucalyptus tree by your department the construction of approach road work is pending since last more than six months. On the other hand no condition was shown/mentioned in the portal to take NOC from Haryana Pollution Control Board when the university was applying online.

In view of above, you are requested to remove the said eucalyptus trees (45 to 50 Nos.) so that the approach road can be constructed time.

An early response will be highly appreciated.
