

STATEMENT SHOWING THE DETAILS OF NON-FOREST AREA INVOLVED IN THE PROPOSAL

The Bhimnath-Dholera greenfield freight rail project is of 24.4 km. length and the alignment passes through Ahmedabad and Botad Districts. Total about 101.37 Hectare non-forest land is required for the project of which 67.36 Ha. land is located in Botad District and 34.01 Ha. land is located in Ahmedabad District. The details of non-forest land area for each district is as below:

The Non-Forest Land of area equivalent to the area required for forest diversion has been identified for compensatory afforestation. The non-forest land admeasuring 15.5 Hectares identified for compensatory afforestation is located in Gogla Village of Dholera Taluka of Ahmedabad District. The proposed land parcels for compensatory afforestation (new survey nos. of Gogla Village 400 admeasuring area 6.8135 Ha., survey no. 401 admeasuring area 6.6563 Ha., and survey no. 404 admeasuring area 2.0302 Ha., total 15.50 Ha.) are under ownership of DSIRDA and are surrounded by a large land parcel (new survey no. 407 of Gogla Village) which is under ownership of Forest Department.
