

We invite your kind attention to the subject and reference cited above, wherein the Principal Secretary, ITE&C Department, Government of Telangana has addressed a letter to all District Collectors in the State to issue the ROFR certificate to T-Fiber project wherever required.

Subsequently, T-Fiber officials have approached the District Collector, Nalgonda for Nalgonda & Nagarjunasagar Forest Divisions, Rangareddy District Collector for Amangal Forest Division and Wanaparthy District Collector for Wanaparthy Forest division towards obtaining ROFR certificates. We are herewith enclosing copies of the letters issued by the District Collectors to the respective Revenue Divisional Officers for ROFR further process. T-Fiber has already initiated the process of obtaining ROFR certificates from other Districts and all are under process.

As you may appreciate T-Fiber project is to be completed on top priority in larger interest of General public, we humbly request you to process the Nalgonda, Nargarjunasagar, Amangal & Wanaparthy Forest division proposals on the basis of District Collector letters. Meanwhile, T-Fiber shall obtain ROFR certificates and submit at the earliest well before Stage-II approval stage.



I invite attention to the reference cited, and it is to inform that the Managing Director, Telangana Fiber Grid Corporation Ltd., Hyderabad has informed that the Optical Fiber Cable is passing through Nellikal, Azmapur, Nidgul, Rajawaram & Nambapur RF of Nagarjunasagar Forest Division of Amrabad Tiger Reserve over a length of 29.12 KMs, involving 1.3105 Ha received from T-Fiber and diversion of 1.0935 Ha of Forest land along the road, within the existing Right of Way (ROW) for execution of T-Fiber project in Nalgonda District. As such, he has requested to issue ROFR Certificate as per ROFR Act, 2006.

In this regard, it is to inform that as per the Scheduled Tribe & Other Traditional Forest Dwellers (ROFR) Act, 2006, the Gram Sabha shall pass a resolution determining the nature and extent of individual or community forest rights and thereafter forward a copy of the same to the Sub-Divisional Level Committee. The SDC shall examine the Gram Sabha resolution and prepare the record of forest rights and forward it through the Sub-Divisional Officer to the District Level Committee headed by the District Collector for a final decision.

In view of the above, while enclosing a copy of the reference cited, you are requested to look into the matter and take necessary action as per rules.


