Forest Area diverted is 0.25 Ha. which is less than 1 ha. And in the diversion of forest area, no trees are involved. Therefore as per Guideline 2.6 of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003, CA Scheme is proposed as mentioned below:

- 1. Since no trees are to be felled, so number of plants to be planted: 100
- 2. Location where plants will be planted (Location of CA Site): 155/N
- 3. Density of CA site: <30%
- 4. Species to be planted: chir, amla, ber arjuna, chir etc.
