In inviting a kind reference to the subject & letter cited above, the diversion proposal is resubmitted after necessary compliance to the points raised by RCCF, Koraput as noted below.

- 7 The required certificate will be furnished in form –I with signature, full name and official seal of the collector cum District Magistrate, Koraput by the Project Administrator, ITDA, Koraput vide response to the Letter No 3049 Dated 05.08.2017 of the Regional Chief Conservator of Forest, Koraput.
- 8 Official seal has now been stamped in the certificate of the Collector, Malkangiri
- 9 In Check List No-18 (Under taken for payment of NPV) may be countersigned at your end.

- 10 The serial no 329 in the tree enumeration list of Jeypore Forest Division, having girth 12 cm, not coming into the criteria of up loading data in web portal. Hence in the web portal total nos of trees in Jeypore forest Division in 1431 in place of 1432 nos.
- 11 In the abstract of tree enumeration list, the number of trees in respect of Malkangiri Division is now corrected to 1407.
- 12 Part – II of the application generated from website may kindly be authenticated at your end.
- 13 Those information which has been hidden in the specific recommendation of DFO, Jeypore Division in Part- II of the application may kindly be corrected at your end.
- 14 Information in Check List Form No – 20 (Site Inspection report) may kindly submitted in prescribed format at your end.
- 15 In the abstract of financial forecast of the Compensatory afforestation, the entry in the last column is now corrected to 10.785 ha.
- 16 In the scheme for Compensatory afforestation at Item No-4 (schedule of plantation programme) area of Compensatory afforestation is now corrected to 10.785 ha.
- 17 In Checklist Serial No- 21, area of Compensatory afforestation is now corrected to 10 785 ha.
- 18 Signature and Seal of the competent authority are done in all required documents and undertakings.
