It is informed that the ETS & DGPS/ GNSS Survey data, of the non-forest land identified for Compensatory Afforestation in Sy.No.479 of Jabithapur Village of Jagithal Mandal in lieu of diversion applied for the following three projects as submitted by the EE, R&B Division, Jagithal vide ref 3rd cited has been verified by the Geomatics cell of this office & **accepted**. The extent of CA land proposed to be taken is estimated as 34.773 Ha. **The maps are enclosed herewith**. These CA lands are stated to be linked to following roads:

- 1. Korutla Mallapur road 7.635 Ha.
- 2. Mediapply Bornappaly road 11.30 Ha.
- 3. Rechapally Thatlawai road 11.584 Ha.

It is informed that the proxy RF boundaries shown on topomaps are used for ascertaining the boundaries of RF & proximity of CA land to RF. The Divisional Forest Officer, Karimnagar (West) is requested to inspect the nonforest land identified for CA for its suitability. The Divisional Forest Officer is also requested to

- 1. To ensure that the land is free from encumberances and encroachments
- 2. To ensure that the land is not part of any notified forest and not received as CA lands for any other projects.
- 3. To ensure that the land is pattaland and not assigned land duly verifying the pahanis, sethwars etc.

The Divisional Forest Officer is also requested to follow the other instructions issued from time to time & furnish detailed report alongiwht the suitability certificate & CA scheme, if the CA lands are suitable for raising CA plantations.

The EE, R&B Division, Jagithal is requested to show the non-forest land identified & allotted by the District Collector to the Divisional Forest Officer

during his inspection to the proposed site for taking early action on your request.

The EE, R&B Division, Jagithal is also requested to furnish the NOC from the District Collector that the CA lands shall be mutated and transferred in the name of the Forest Department upon receipt of Stage-I approval alongwith the non-encumberance certificate, if the CA lands identified are suitable for raising Compensatory Afforestation. The format is appended herewith.

The EE, R&B Division, Jagithal is also requested to deposit an amount of Rs.6,000/- in the shape of DD drawn in favour of Joint Secretary, CEFNARM, Hyderabad towards verification and authentication charges of DGPS Survey Data.
