The necessary No Objection Certificate for construction of proposed
Ambulance road to Ward No.1 Kandi & Dugiriuni Km. 0/000 to 1/215, 0/000 to 0/525 and 0/000 to 0/600, MC
Rampur District Shimla-HP as desired vide your letter under reference is hereby accorded subject to the
following conditions:-

1. In this regard, it is intimated that No Objection Certificate can be issued with condition that during the construction work of road as per alignment of pipe line 100mm dia from Sarla Parog to Shish Mahal is being existed between RD 0/50 to 285, if any, pipe line will be damaged during the construction work of road will have to be maintained/repared immediately. All kinds of damages, risks, losses, claims to Govt/public property and claim of personal injury/death, if any, which occurs during the course of execution of the said work shall be the whole responsibilities of the executing authority i.e. Municipal Council Rampur Bsr.
2. That the construction of said work done by the Municipal Council, Rampur Bsr without creating any hindrance to supply the water to the general public.
3. That the executing agency shall be fully responsible to supply the water regularly to the beneficiaries of the aforesaid area.
4. The executing agency will be fully responsible if there will be any damaged to the said pipe line works and others, the same will be restored by the agency at their own cost.
5. During the construction/laying of pipe line of the said RD any kind of damages to the forest and violation environment act, the agency will be fully responsible for the same.
6. The Irrigation-cum-Public Health Department reserves the right to withdraw the NOC issued to the Municipal Council, Rampur Bsr. in case of violation of above conditions and due to any other reasons which may affect public concern and the agency shall have no right to raise any claim against said withdrawal.
