Sir,

The necessary No Objection Certificate for construction of proposed Ambulance road to Ward No.I, Kandi & Dugiriuni km 0/000 to 1/215, 0/000 to 0/525 and 0/000 to 0/600 MC Rampur Distt. Shimla (HP) as desired vide your letter under reference is hereby accorded subject to the following conditions: -

That the construction of road will be done by the Municipal Council, Rampur Bsr. without creating any hindrance to traffic and inconveniences to the general public without any damages to public and private property.

In case any damages occurred to the PWD R.G.M. road during the construction of above road the executing agency will bear the cost of damages.

All risks, losses, claims, damages to Govt./public property and claim of personal injury/death, if any, which occurs during the course of execution of the said work shall be the sole responsibilities of the Municipal Council, Rampur Bsr.

Dumping site for disposing of surplus muck should be identified and developed by the agency at its cost before executing said work. It shall be sole and exclusive responsibility of the Municipal Council, Rampur Bsr. that suitable and safe dumping sites shall be created by it at their own cost so that all surplus materials are stacked over there. The surplus material shall not be disposed off anywhere else except in the approved dumping sites.

- The Municipal Council, Rampur Bsr. will be fully responsible to provide protection works for stability of slopes as well as for safety of public/private properties.
- The agency shall be responsible for regulation of traffic during construction of said road and shall take all action to maintain traffic on PWD R.G.M. road.
- 7 Mandatory & Statuary instructions as well as law of land shall be followed/complied strictly.

- The executing agency will be fully responsible to provide protection for the existing PWD R.G.M. road if there will be any damage to said road the same will be restored by the agency at their own cost.
- During the construction of said road any kind of damage to the forest and violation of environment act, the agency will be fully responsible for the same.
- The Public Works Department reserves, its right to withdraw the N.O.C. issued in case of violation of above conditions and due to any other reason which may affect public concern and the agency shall have no right to raise any claim against said withdrawal.
