WILD LIFE (PROTECTION) ACT, 1972.

No. GVN-28-90-WLD-1086-1653-V2. —Whereas the Government of Gujarat considers that the area, the limits of which are defined in the schedules annexed hereto is of adequate, ecological faunal, floral, geomorphological, natural and zoological significance for the purpose of protecting and developing wild life and its environment.

Now therefore, in exercise of the power conferred by section 18 of the Wild Life (Protection) Act, 1972 (53 of 1972), the Government of Gujarat hereby declare the areas of following villages of Halol and Jambughoda Talukas of Panchmahals district and Sankheda taluka of Vadodara district specified in the schedule annexed hereto as a "Jambughoda Wild Life Sanctuary".
