
Subject: Issue of NOC for construction of Sangmeshwar Polytechnic College in
Km 14 of Thanesar Jhansa road

Reference: Your application No.SET/08 Dated 24-03-08

In this connection, it is intimated that this office has no objection for construction of Sangmeshwar Polytechnic College in Km 14 of Thanesar Jhansa road in Distt. Kurukshetra with the following conditions.

1. There should be no encroachment on PWD land at the time of execution of work and also thereafter.
2. The top level of the approach road to the institute should be lower than the existing road and gradient should be 5%.
3. The X-drainage will be provided in the approaches indicated in the plan with the disposal. Drain should be constructed and covered with proper slope to avoid water accumulated of water on the road.
4. No pucca structure will be constructed within 30 Mt from the PWD land boundary as per Schedule road Act 1963 to obstruct the visibility of the road users. The radius of curve of approach road to Institute should be as per I.R.C. specification and not less than 13 metre from the PWD Boundary's.
5. The distance from a junction should not be less than 130 metre i/c radius as per I.R.C. clause-4.7
6. Lease money as per rule will be deposited well before time with agreement with the State PWD deptt. be executed before construction of the approach road to Institute.
7. As per Clause 4.6 of I.R.C. 12-1983 there should be no interference to the future extension of the road.
8. The approach road is to be allowed only through service lane of constructed with his own cost.



Hence, this information is being given subject to following conditions:-
