

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

(For the forest land to be diverted under FCA)

A proposal has been received by the this office from मण्डलीय अभियन्ता, दूर संचार परियोजना, मुरादाबाद से राष्ट्रीय मार्ग स ० 24 (न्यू 530) के किमी 214 से परसाखेरा ,सी० बी० गंज, दूरभाष केंद्र चौपला बरेली से होते हुए किमी 250 तक ,कुल दूरी 36 कि०मी० में बायीं पटरी पर , ओएफओसी० बिछाने हेतु diversion (under FCA-1980) of 1.08 hac. of forest land for non-forestry purpose. The project envisage the use of forest land for laying. The site inspection of the land involved in the proposal has been done by me on dated. 07.10.2017

On inspection of the site, it is found that the land required buy the user agency is a PF/Protect forest measuring. PF **1.08** hac.
