Specific Condition :

- 1 A. That this Acknowledgement is being issued for dispensation of petroleum products: 1450 Liter/day.
- B. That the industry shall not discharge treated trade or domestic effluent or establish water treatment facility without obtaining prior Consent to Establish and/or consent to operate from the State Board under the provisions of water (Prevention and Control of Pollution) Act, 1974.
- C. The applicant/Industry/Process/Project shall have to comply with the provisions of water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 and the standards prescribed there under along with the general guidelines and/or direction issued by the Central Pollution Control Board or the Rajasthan State Pollution Control Board time to time.
- D. That ground water shall not be abstracted without prior approval of Central Ground Water Authority.
- E. That this acknowledgement is being issued on the basis of documents/ information uploaded by the applicant/ industry/ process/ Project. The liability of veracity and correctness of the uploaded documents/ information shall solely be of the applicant only.
- F. In case, any direction for closure has been issued by the state board for the same premises and has not been withdrawn, then this acknowledgement shall not be considered as Consent, in any case and shall be treated null and void.
- G. Any wrong or partial information/ concealment of facts or deviation from material facts shall make this acknowledgement null and void.
- H. That this acknowledgement of consent application shall cease to be valid in case of any change in product/ process/operation/raw material/capacity/area or in information/document submitted/uploaded at the time of seeking consent.
- I. That submission of any incorrect/partial information/false documents or concealment or misrepresentation of material facts shall make the applicant/industry/process/ project liable for legal action, jointly as well as severally, under the provisions of the Indian Penal Code, 1860, information technology Act, 2000, Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986, which may include imprisonment and/or penalty as per the provisions of statutes.
- J. This acknowledgment of consent application will not be used as an evidence for ascertaining the land title and its use.
- K. That this acknowledgment of consent application is valid subject to fulfillment of all the other statutory requirements in other Laws / Acts / Rules as applicable.
