A proposal has been received by this office from NHIDCL for the diversion (under FCA-1980) of 1.28235 ha. of forest for non forestry purpose. The subject envisages the use of forest land for Construction and up gradation to 2 lane with paved shoulder from Km 80.675 (Start of Kishtwar by Pass) to KM 95 +550 (end of Helmet top by pass) of length 14.875 Km and link road from 0+000 to 1.871 of length=1.871 km total length=16.746 Km (including link road) on Khellani-Kishtwar-Chatroo-Khanabal section of NH-244 in the Union Territory of Jammu & Kashmir (PKG-IV). The site inspection of the land involved in the proposal has been done by me on dated 01-9-2021.

On inspection of the site, it is found that the land required by the user agency is a forest measuring 1.28235 ha.

The requirement of forest land as proposed by the user agency in col. 2 of part-1 is unavoidable and is barest minimum required for the project.

**Specific recommendation for acceptance or otherwise of the proposal.**

The length of the road from Dulhasti to Bhandarkoot is 14.88 Km and link road to Kishtwar town is 1.871 Km. The total length of the road is 16.751 Km, whereas only 0.557 Km passes through forest area involving an area of 1.28235 Ha. Further the proposed alignment is important from connectivity point of view and also redresses the travel time in surrounding areas and would promote the development of the area.
