The communication addressed to Deputy Commissioner concerned for FRA need to be uploaded at additional documents in part-I by the user agency.
3. The detail of non-forest land identified for compensatory afforestation be provided under Column.
4. A proposal for diversion of forest land for irrigation/hydro-electric projects shall invariably be accompanied by detailed CAT Plan and approved by Pr.CCF (HoFF) or any other officer authorized by him for the purpose. The CF/DFO/UA are requested to present their CAT Plan by giving power point presentation so that same can be placed before the PCCF (HoFF) J&K for approval
