Sub: Diversion of Underground Forest land in respect of Uri – 1 Stage – II H E Project – FRA thereof. Sir,

The proposed project Uri 1 stage II HE Project will utilise the already completed structures of existing Uri – 1 stage – I including Barrage, Cut and cover culvert, desilting basin, Open power channel, Adits. A parallel separate HRT is proposed to be constructed for Uri –I, Stage-II HE Project along with surge shaft, pressure shafts and a separate underground power house (near the existing underground power house of Uri-I Power Station).

In this regard, an indent for proposed diversion of Forest land required for the project components viz HRT, surge shaft, pressure shafts and underground power house TRT and other allied structure, shall fall underground and as such there will be no diversion of surface forest land, as well as the diversion of forest land will not involve any tree cutting. The application for diversion of underground Forest land for the project has been initiated online through PARIVESH portal. It is expected that 17 hectare of underground forest land shall be required for diversion purposes.

It is to mention that the forest land to be diverted will be underground area and as such there is no habitation coming in the proposed underground forest land and the population will not be affected the construction acavities in the underground forest land. As per the requirement of Forest Act, it is requested that the inhabitant of the area falling under the proposed 17 hectare of underground forest land, if any, may be rehabilitated under recognistion and vesting of forest rights in accordance with the provisions for Scheduled tribes and other traditional forests dwellers under FRA 2007.

Respected Madam,

Forest clearance proposal for Uri-I Stage-II HE Project is in process through Parivesh Portal. The project involves 17 hectares of underground forest land for construction of various components. There will be no diversion of surface forest land. Also, there will not be any tree cutting involved for the construction of the Uri-I Stage-II HE Project.

Since, only underground forest land is involved, hence, no habitation will be affected by the construction of the proposed Uri-I Stage-II HE Project. However, as a part of the procedure under "Recognition and Vesting of Forest Rights" in accordance with the "Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006", the resolutions of Gram Sabhas of villages which fall under the alignment of the Project, is a part of Forest Clearance proposal. Accordingly, Gram Sabhas were conducted by NHPC as detailed below: -

At Panchayat Halqa Machikrend and Mohura i.r.o. villages Mohura and Rajarwani Bandi: On 05.08.2022.

ii) At HQ Chandanwari i.r.o. Panchayat Halqa Uranbua and Boniyar: On 06.08.2022

The resolutions passed by the Gram Sabhas were forwarded by the Asstt. Commissioner Panchayat, Baramulla to Deputy Commissioner, Baramulla vide letter referred at SI. No. 8. Copies of the same are enclosed herewith.

Since, the forest clearance proposal of Uri-I Stage-II HEP has been processed under Forest Rights Act (Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, therefore, in compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11- 9/98-FC (pt.) dated 3rd August 2009, a certificate in the prescribed format (enclosed) is required to be issued by the concerned District Collector based on Gram Sabha Resolutions.

to view of the above, it is requested that the certificate in the prescribed format may please be issued in favour of Uri-I Stage-II-HE Project so that further action for grant of Forest Clearance may be initiated.
