Preamble.

In Government Order dated 9/11-4-1973 cited (1) an extent of 5 acres of land out of F.S.No. 232 of Sirsi, North Kanara District was ordered to be leased to Shri M.V. Joshi for establishing Small Scale industries, for a period of 5 years subject to certain terms and conditions.

In Government Order dated 27-3-1974 cited (2) the period of lesso has been extended for a period of 15 years.

In their letter dated 11-4-1974 cited (3) We Karnataka State Financial Corporation suggested some altered conditions, including the period of lease to be extended for 25 years so as to sanction loan to the leases.

Government have agreed to all the conditions suggested by the Karnataka State Financial Corporation.

- In supersession of G.O. No. AFB 443 FGL 73 dated 27-3-1974 Government are please to modify the G.O. No. AFD 213 FGL 72 dated 9-11-443 1973 to the extent noted bellow.
- 1. The period of lease wanshell be 25 years.
- 2. Before terminating the lease for voilating of any conditions, Government will exarcise their right under the lease efter a written notice to Karnataka State Financial Corporation 3 months in advance.
- 3. The leases is permitted to mortagage or assign the lease-hold rights in favour of the Karnataka State financial Corporation subject to the condition that the leases executes an agreement in this behalf and further that in the event of any default on the part of the loans to the financial Agency or under any other circumstances, the title of the Government of Karnataka on the said land would remain unaffected.
- 4. The lesses is permitted to put up permanant structures on the land.
- 5. The land should be utilised by the partnership firm M/s Sahyedri Papers
- 6. The leases shall nor exercise his right under any provision to terminate the lease without the praior permission of Karnataka Stats Financial— Corporation as long as the lesses is a debtor to the Corporation.
