Please refer to your application Serial Number DEL/PYL/PNPT-1/010 on subject and the subsequent draw held for selection at Piyala on 10.05.2016.

It is intended to offer you LPG Distributorship at **PANIPAT-1, DISTT. PANIPAT** on conditions that you will:

#### 1. LPG STORAGE GODOWN & SHOWROOM

You should provide a godown for storage of 8000 kg (minimum) of LPG filled in cylinders. The LPG Storage godown should be approved and licensed by Chief Controller of Explosives of Petroleum and Explosives Safety Organization (PESO) and should have mastic flooring. You should also have a showroom of dimensions 3m X 4.5 m in the advertised location or locality specified in the advertisement. The construction of godown and showroom should be completed within a period of four months from the date of this letter. Both godown and showroom should be freely accessible through all weather motorable approach road. Construction of godown / showroom should be commenced only after permission in writing is obtained from this office.

#### 2. FINANCE

Make all financial and other arrangements for operating the Distributorship within **four months** from the date of this letter.

#### 3. DELIVERY INFRASTRUCTURE

Make arrangements for delivery vehicles for effecting home delivery of LPG cylinders.

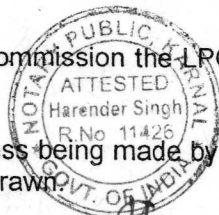
#### 4. PERSONAL SUPERVISION

You should personally manage the LPG distributorship operations. If already employed, you will have to submit acceptance of resignation letter from your employer prior to the issuance of Appointment Letter by us. In addition to the above, you will also submit a Notarized Affidavit certifying that you are not employed in private sector or are not drawing any salary/perks/emoluments (other than pension) from the State/Central Government before the issuance of Letter of Appointment by us as per the attached format.

#### 5. COMMISSIONING

5.1. Make all out efforts to commission the LPG Distributorship within four months from the date of this letter.

5.2. If we find that the progress being made by you towards the above is not to our satisfaction, this offer is liable to be withdrawn.

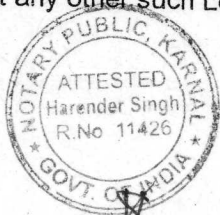


