		above deficit HPPCL has dumped muck on private land on specific request of the local people. In addition to above forest land measuring 5.2248 ha. at four location have been requested for diversion in instant proposal for dumping of muck. Justification to this effect has been attached as Annexure-A .
3	Govt. of Himachal Pradesh vide their letter dated 16.07.2023 reported that a committee has been formed to assess the capacity of all the designated dumping sites and the revised muck management plan will be finalized after finalization of land. Accordingly, the approved muck management plan shall be submitted.	Final Muck Management Plan of the propose site has been attached and same has been sent for approval to HPSPCB. The approved muck management plan will be submitted before Stage-II approval. Under taking to the effect of submission of the plan is attached as Annexure-B .
4	The State Govt. shall submit the details of funds deposited towards revised CAT plan in National Authority and its confirmation which is not available with the Ministry. The reason for slow progress in implementation of CAT plan shall be given.	In respect of Shongtong Karcham HEP Rs 60.44 Crore were deposited in CAMPA account on dated 01.10.2012 against CAT plan. Balance funds amounting to Rs 9, 75, 57,500/- were deposited towards revised CAT plan in CAMPA account on 12.07.2023. Copy of both the receipt with UTR number is enclosed as Annexure-C . Reason for slow progress of implementation of CAT Plan is in the preview of HP Forest Department.
5	The State Govt. shall submit a detailed report in connection with compliance of condition no. 15 of approval dated 14.11.2022 regarding regeneration of equivalent area of degraded forest land.	As per the progress report on activities implemented under "Regeneration of Equal amount of degraded forest land project Proponent has deposited Rs. 1,36,73,737/- which has been fully utilized as per progress report for the year 2016-17 & 2017-18 conveyed by DFO Kinnaur. Copy of progress report and utilization certificate is attached as Annexure-D . The detailed report in compliance to condition No. 15 is in the preview of HP Forest Department.
6	There is a violation over an area of 0.5883 ha. as reported by the State. The justification and action taken report in this regard shall be submitted by the State.	It is submitted in the matter that the Shongtong Project is a flagship project and the largest one undertaken by GoHP so far. Due to various reasons project has got delayed. The stated violation has happened in silt flushing area which is critical for the commissioning of the Project and is getting completed as a last activity of the project. The instant FCA proposal which seeks diversion of this patch of land was submitted way back in October 2019; however, due to repeated objections at different levels the proposal is still not approved. HPPCL had started the work with the hope that proposal will get through in due course. So the work was started with greater public interest in mind and not due to any vested interest. In any case DFO Kinnaur on 18.01.2023 has penalized Project proponent with Rs. 41,21,058.0 with 12% interest from the date of reporting violation. The

		works on area in question is also completely stopped and no construction activities are going on.
7	The reservoir to be created due to submergence is required to be declared as Reserve Forest under Indian Forest Act. 1927. A copy of notification for the same shall be submitted.	Project proponent has taken up this matter with DC & DFO Kinnaur. The DC Kinnaur has requested DFO Kinnaur to take further necessary action, as per Indian Forest Act 1927. It is however submitted that declaration is a time taking process as there is certain SOP to be followed. It is to be undertaken the same will be complied before the commissioning of Project. The works of project are already delayed and this diversion is very critical for the progress of the Project. It is therefore requested that the two issues may not be linked.
8	The area of 1.8248 ha. for the components of instant diversion [Adit-I (0.5883), Dumping site below Adit-I (1.1005 ha.) and Road to RBM Site (0.136 ha.)] is overlapping with the 'Barrage' component of earlier approved forest area (63.5015 ha.) which need clarification with correct KML file.	Area measuring 0.5883 ha. for Adit -I & 1.1005 ha. for dumping site below Adit -I is included in the instant proposal of additional FC case of Area measuring 7.3722 ha. A portion of the road to RBM site measuring 0.1360 ha. was inadvertently left out in previous proposal due to its proximity with the larger patch diverted in original proposal of 60.5015 ha. Therefore this patch was included in the present proposal. As far as overlapping of the area with Barrage component is concerned the same is being rectified.
9	The KML file of earlier diversion of 63.5015 ha. Shall be uploaded on PARIVESH.	KML file of earlier diversion of 63.5015 ha. was provided in the shape of CD against observation at 'Para no 8' of previous reply of HP state Govt. dated 16.July 2023, however, the same is being uploaded on PARIVESH portal.






