MINUTES OF THE MEETING OF RIDGE MANAGEMENT BOARD HELD ON 14.07.2021 AT 11:00 AM UNDER THE CHAIRMANSHIP OF CHIEF SECRETARY. DELHI & CHAIRMAN. RMB

The meeting of Ridge Management Board was held on 14.07.2021, Wednesday at 11:00 AM under the chairmanship of Chief Secretary cum Chairman RMB via Video Conferencing. The list of attendees is attached.

At the outset, the PCCF & Member Secretary, RMB welcomed all the Board members.

Thereafter each agenda was discussed by the Board and decisions were taken as listed below:

1. Agenda Item 1: Construction of metro line (Aerocity-Tughlakabad corridor) of Delhi MRTS Phase-IV

(UA: Delhi Metro Rail Corporation)

The Board was apprised that DMRC had submitted a proposal for use of forest land for the construction of Metro line, stations and other operational requirements of Delhi MRTS Ph-IV. The proposed corridor is passing through Mahipalpur (along Mahipalpur-Mehrauli Road), Kishangarh, Chhattarpur, IGNOU, Saket (Mehrauli-Badarpur road) and Anandmayee Marg T Junction. The length of the tunnel (U/G portion of the alignment) falling under Southern Ridge, South Central Ridge and Morphological Ridge is 1739 m, 1182 m and 2373 m respectively involving 4.5 Ha. land area. The User Agency has mentioned that use of this area shall not involve surface breaking and tunnelling will be carried out with the help of Tunnel Boring Machines (TBMs); rest 8.4 Ha. area is required for construction of metro stations. Details are as tabulated below:

It was informed that in the last meeting of Ridge Management Board held on 03.06.2021, the Board had directed that Forest Department and DMRC should thoroughly explore all the alternative alignments for the MRTS corridor and overlay all those alternate alignments on a map of Ridge/ Morphological Ridge which should be presented before the Board, in the next meeting.

In compliance with the directions of RMB, joint meetings were held between DCF (South) and officials of DMRC on 08.06.2021, 11.06.2021 and 17.06.2021 for assessing the alternative routes at 4 locations where the MRTS corridor is passing through the Ridge/ Morphological Ridge area. A detailed presentation was prepared and discussed with PCCF. From the comparative study of alternatives proposed, following conclusions have been drawn:

- i) **At Mahipalpur**, the alternate location involves 226 trees in the Ridge area as against 132 trees in the proposed location submitted to RMB. Construction in alternate locations also involves demolition of built up areas and children burial ground.
- ii) At Kishangarh, the alternate station location falls in a deemed forest area involving tree cutting. The alternate location involves 748 trees mostly in deemed forest area as compared to 455 trees in the proposed location submitted to RMB. Also the alternate station is approx. 600 m away from the important T junction of Aruna Asaf Ali Marg and Mehrauli- Mahipalpur road thus making it inconvenient to the commuters, increases distance from Kishangarh village, Mehrauli villages & Fortis hospital and imbalances the inter station distances. The proposed station location submitted to RMB is at the T Junction.
- orientation so as to have the least length of tunnel through Ridge near IGNOU. However, on detailed study, it has been found that this alternate location involves more area in Ridge for station construction as it is at higher ground level involving more width for side slopes due to deeper excavation. Also the alternate location is away from the Main Road, therefore an additional ridge area will be required for making the approach road to the station. Further the marginal reduction in the tunnel length through Ridge due to reorientation at this location is offset by the entry of tunnel in ridge area at other locations at Maidangarhi. Thus the overall ridge area required will be more than the proposed station location on the road submitted to RMB. The number of trees to be cut in alternate locations are 1140 as compared to 334 nos in the proposed station location given to RMB.
- iv) At Maa Anandmayee Marg Station, due to the constraint of prohibited area of protected monuments, the shifting of alignment and station is restricted. The only alternative available is to shift the station in the built up area along the road where the road width is insufficient for station

construction and traffic diversion during construction and thus involves demolition of large built up areas. It also imbalances the interstation distance of Maa Anandmayee Marg station from the adjacent stations.

A table showing comparative analysis of all the alternatives analyzed is attached as Annexure-1 to the minutes.

After thorough deliberations in the RMB meeting, it was agreed by the Board that the original alignment proposed by DMRC is the most suitable one as it involves minimum use of Forest area (i.e. 12.9 Ha.) and minimum felling of trees (i.e. 1072). In view of the facts, the Board decided to recommend the proposal to Central Empowered Committee subject to the following conditions:

- a. The User Agency shall obtain necessary permission for diversion of forest area for non-forestry purposes as per provisions under Forest (Conservation) Act, 1980.
- b. The User Agency shall deposit 5% of the project cost proportionate to the area falling within Morphological Ridge area to RMB fund on the lines of conditions imposed by Hon'ble Supreme Court of India in WP (C) 202/1995 titled T. N. Godavarman Thirumulpad Vs Union of India & Ors. for management of the ridge.
- 2. Agenda Item 2: Request for N.O.C for the layout plan of Comprehensive Management Plan of Mehrauli Archaeological Park.

(UA: Delhi Development Authority)

The Board was informed about the proposal received from DDA for N.O.C. for the layout plan of the Comprehensive Management Plan of Mehrauli Archaeological Park. The total area of the site is 75.49 Ha. The management Plan has been formulated as per Hon'ble High Court of Delhi's order dated 17.05.2017. DDA had planned to develop various public amenities in the Park such as Nature Interpretation Centre, Restaurant, Toilets, Shelters, kiosks etc. A general N.O.C. is being sought, DDA will take separate N.O.C. for construction purposes. The total no. of trees in the entire plot area is 719.

As the entire area falls within South-Central Ridge, the Board in its meeting held on 05.03.2021 desired that a meeting should be conducted by the Forest Department with the Sr. Architect of DDA in order to develop a plan showing holistic view of the entire Park, and the development of amenities should be done in an ecofriendly manner and use of concrete should be discouraged.

Accordingly, a meeting was held by PCCF on 05.07.2021 in which the Sr. Architect DDA presented a plan showing a holistic view of the entire park and the development of amenities. In the layout plan prepared by DDA, the boundary of Ridge/ Morphological Ridge was not depicted; PCCF asked the Chief Architect to superimpose the layout of Mehrauli Archaeological Park on the Ridge/ Morphological Ridge boundary. For development purposes, the Mehrauli Archaeological Park is divided in 04 zones:

- In Zone 1, DDA has proposed the facilities like toilet blocks, centres of public kiosks, open air theatre and 4m wide track (in addition to the already existing path) for battery operated vehicles for the visitors.
- In Zone 2, outdoor exhibition areas, community interactive areas, public utilities, nature interpretation centres & restaurants have been proposed.
- In Zone 3, nature trails, machan and bird park have been proposed.
- In Zone 4, a rock garden, Ecological centre/ park, Herbal Garden, Nature Interpretation Centre in existing picnic huts have been proposed.

There are 3 entry gates to the park. Parking is proposed near 02 entry gates. One parking lot is proposed inside the park.

After thorough deliberation on all the zones, PCCF advised DDA to reduce the width of the outer road for battery operated vehicles from 4m to 2m and to make the road as one way only. However, the Chief Architect insisted on a 2.5m wide road for the same. It was also advised to exclude restaurants and open air theatres from the Ridge area. It was further advised to reduce the number of toilet blocks from 08 (eight) to 04 (four) including 02 (two) already existing toilet blocks. The parking proposed inside the park may also be shifted near the entry gate. High rise machan is also not advisable in the park as it may disturb the wild animals in already existing forest areas. Zone 4 has good forest and therefore it was advised to minimise the number of roads/ pathways to reduce the possibility of animal-human conflict as this area is having a good presence of wild animals. The Chief Architect DDA, was asked to change the layout plan accordingly.

The Sr. Architect DDA informed that all the observations made by PCCF in the meeting held on 05.07.2021 have been taken into account and the layout plan has been modified accordingly. A detailed presentation of the modified layout plan was made by her before the Board.

The Board decided to recommend the proposal for consideration of the Central Empowered Committee subject to the following conditions:

- a. The User Agency i.e. DDA shall furnish complete information regarding the Road passing through the Mehrauli Archaeological Park, before the proposal is submitted to CEC for consideration.
- b. The User Agency shall obtain necessary permission for diversion of forest area for non-forestry purposes as per provisions under Forest (Conservation) Act, 1980.

3. Agenda Item 3: Review of process for Final notification of Forest land under Section 20 of Indian Forest Act, 1927

The Member Secretary placed the progress of final notification of Forest Land under Section 20 of IFA, 1927 before the Board members. He informed that the Second meeting of the Oversight Committee was convened on 16.03.2021. After this meeting the Department of Forest and Wildlife, GNCTD in coordination with Revenue Department have taken the following steps to comply the directions of Hon'ble NGT:

a. Status of Tatima proceedings: Notices were issued for Tattima proceedings in the month of March and April. However, they could not be taken up due to Covid-19 Pandemic.
