Sir,

This is in reference to your office letter marked at ref (i) vide which you have submitted the proposal to obtain NOC for the construction of police post building at Khasra No. 1/2/1 measuring 0.2099 ha at Village Jutogh, Distt. Shimla (HP).

2. The NOC for execution of work at the aforesaid location on NH-205 for construction of police post building at Khasra No. 1/2/1 measuring 0.2099 ha is hereby accorded based on the site visit conducted on 20.05.2022 in the presence of representative of NHAI. This NOC is subject to following conditions:-

- (a) The subject forest land is outside ROW of NH-205. Hence, construction of Police post shall be done after leaving setback of 5m width from ROW of NH-205.
- (b) During construction of police post building at the said location, all the safety measures to be ensured by the executing deptt. and there shall be no hindrance in the movement of traffic.
- (c) The construction material to be used for above works shall not be stacked on bituminous pavement of NH-205.
- (d) The radius of turning & non-turning curve for entry & exit ramp from NH-205 shall be as per table given below:

Radius of Turning Curve	Minimum: 13m
	Maximum: 30m
Radius of Non-Turning Curve	Minimum: 1.5m
	Maximum: 3m

(e) HP Police deptt. shall ensure that no permanent structure shall be constructed within ROW of NHAI, else the instant permission will be
