2	Total mining lease area is 295.40 ha. where as in uploaded KML it is found as 925.00 Ha.	While accepting the FC proposal vide no. FP/JH/MIN/36228/2018 of 101 Ha at ED Nodal Office, it was already communicated as additional information with reference to our reply vide letter no. PO/PEOCP/Forest/2019-20/3663 dated 01.09.2019, that, "Earlier Land schedule was uploaded of lease hold area i.e. 922.17 of Parej East Opencast Project approved by revenue officials. Now, Land schedule of approved area under revised Project report of PEOCP has been approved by the revenue officer, which is of 399 Ha. land: As per this land schedule, Notified forest land = 105.67 Ha. GM JJ land = 98.29 Ha. Non-forest land = 195.04 Ha. Out of 105.67 Ha. Notified forest land, 43.52 ha. has already been diverted vide 8-209/91- FC dated 28.04.1993. 7.10 Ha. Land was diverted vide 8-209/91-FC (vol-II) dated 17.07.2008. Diversion of 2.71 Ha. land is being applied with this application. Remaining 52.34 Ha. forest land is not to be utilized by Parej East Opencast Project. However, KML of Revised project boundary of area 399.00 Ha. is being uploaded.
3	Applied forest area is 101 Ha. where as in C. (II)(B)-Patch wise are mentioned is 98.27 ha. which mismatches with applied area.	Due to typographical inadvertent mistake the area of Patch 12 was written as 37.36 Ha. instead of 40.09 Ha. Area of Patch 12 has been corrected.
4	On patch no. 3, 4, 7 & 12 some construction is seen.	On patch no. 3, 4, 7 & 12 some construction is seen in the forest land of proposal 101 ha., because 55.20 ha. GMJJ land and 1.57 Notified Forest Land is already broken at the time of FC application. In this regard a letter was also written to you vide letter no. GM (H)/P&P/21-22/440 dated 23.12.2021. (Copy enclosed)
5	On KML, Patch no. 6 of proposal no. FP/JH/MIN/36228/2018 is inside patch no. 1 of Proposal no. FP/JH/MIN/36448/2018	Proposal no. FP/JH/MIN/36228/2018 is for 101 Ha forest land in which 2.71 Ha. is notified forest land and 98.29 Ha. is the GM JJ Land. Proposal no. FP/JH/MIN/36448/2018 is of 43.52 ha. in which total forest land is 43.52 ha. notified forest land. Patch no 6 of proposal no. FP/JH/MIN/36228/2018 is inside the patch no.1 of proposal no. FP/JH/MIN/36448/2018, the reason is that patch no 6 is of GMJJ land and it was not applied in the 43.52 ha of which Stage II FC was granted vide letter no 8-209/1991-FC dated 28.04.1993. GMJJ

		land was not included in the forest land diversion proposal before 25.12.1996.

FP/JH/MIN/36228/2018 is for 101 Ha forest land in which 2.71 Ha. is notified forest land and 98.29 Ha. is the GM JJ Land. Proposal no FP/JH/MIN/36448/2018 is of 43.52 ha. in which total forest land is 43.52 ha. notified forest land. Patch no 3 of proposal no FP/JH/MIN/36228/2018 is inside the patch no .2 of proposal no FP/JH/MIN/36448/2018. the reason is that patch no.3 is of GMJJ land and it was not applied in the 43.52 ha of which Stage II FC was granted vide letter no. 8-209/1991-FC dated 28.04.1993. GMJJ land was not included in the forest land diversion proposal before 25.12.1996.
