Lands excluded :-

(1) Land enclosed between the present deep stream of the Katna river, as demarcated by serially numbered monoliths nos 7 to 9 placed on alternate banks and the old bed of the same river lying to the east of the present bed.

(2) Out of 433.6 acres bounded as follows,
North-east - A cut line running from former forest boundary pillar no. 18 through monoliths serially numbered from 70 to 86, to former forest boundary pillar no. 74.

South and West - The former forest boundary from pillar no 18 to pillar no 74,
308 acres belongs to Faridpur.

Description of Boundaries (extract from notf^o no. 478/XIV-149 of 12th July 1917)

Lands included :-

Out of 40.8 acres 20.4 acres of Mohraghat belongs to Faridpur.
Boundaries of Mohra flat :- Land enclosed between the present deep stream of the Katna river, as demarcated by monoliths numbered 25 and 26 placed on alternate banks and the old bed of the same river lying west & south of the present bed.

Boundaries of Faridpur (453.1 aco)

North-east - The original boundary of the reserved forest from pillar no 74 to pillar no 271.

South - A cut line from pillar no 74 to monolith no 87 at the Munda - Ghahil - Banjaria - Faridpur trijunction pillar

West :- From monolith no 87 at the Munda - Ghahil - Banjaria - Faridpur trijunction pillar, along the outer boundary of the forest, marked by a 2' x 2' ditch as well as by serially numbered new monoliths nos 88 to pillar no 102, at the old forest boundary pillar no 271.
