No. 3008/XIV.—Whereas the Governor, Uttar Pradesh is of the opinion that the making of inquiry and record contemplated under section(3) of section 29 of the Indian Forest Act, 1937 (Act no. XVI of 1937), will occupy such length of time as in the meantime to endanger the rights of the State Government.

Now, therefore, in exercise of the powers conferred by the proviso to the aforesaid subsection and by sub-section(1) of the said section, read with section 80-A of the aforesaid Act, he is pleased to declare that pending such inquiry and record, the provisions of Chapter IV of the said Act shall be applicable to the lands specified in the Schedule hereto :
