2. 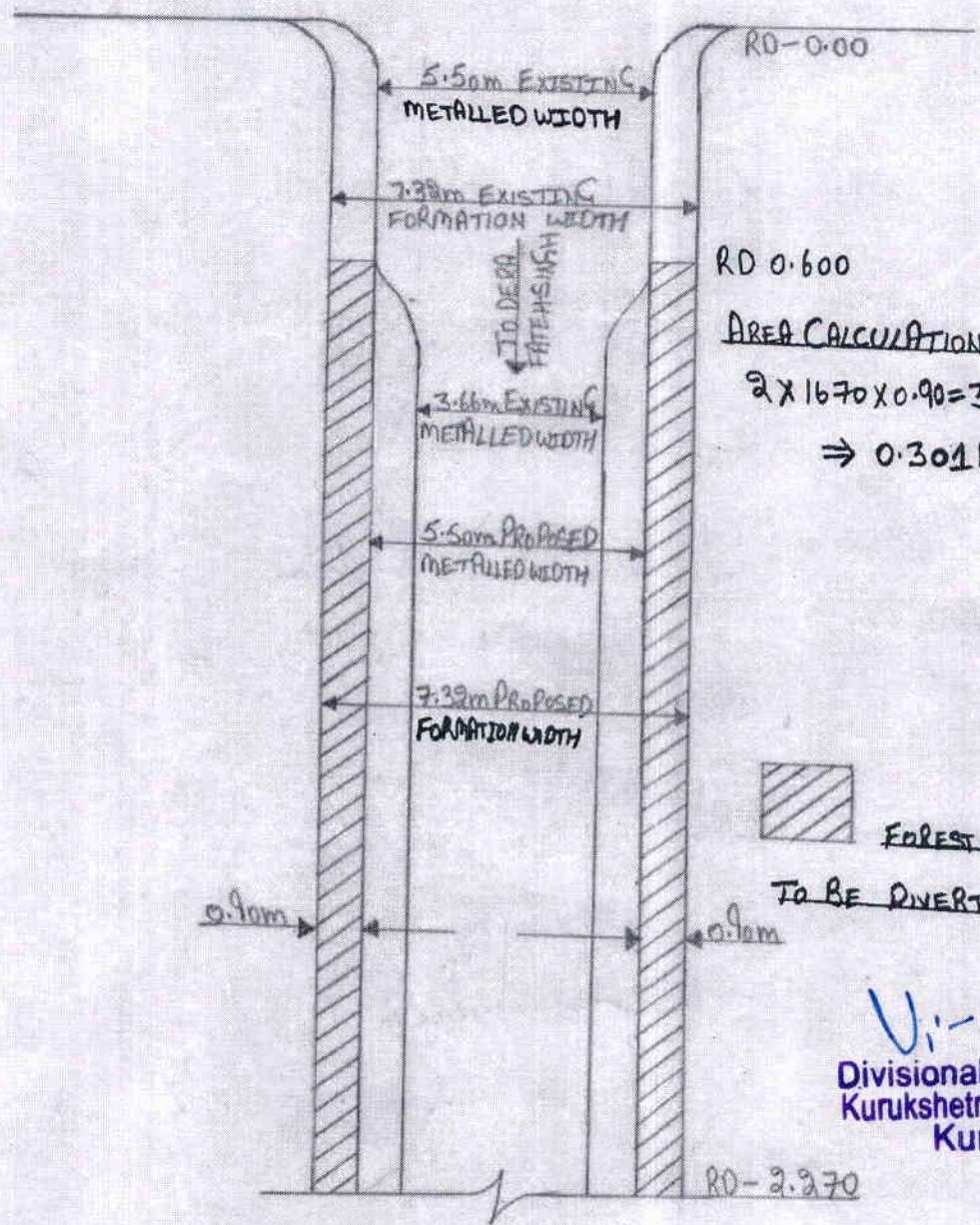
