Namaste. Please accept our humble regards. As per the letter from your office having No.A5(2).GFL.CR-4/2018-19, dated 15/09/2018 we have been told that the option "NO" for the SI No. K(i) Whether the process for settlement of Rights under the Forest Rights Act 2006 on the forest land proposed to be diverted has been completed? Is not correct and we have to submit the RoFR Compliance Certificate in FORM-II (for Hybrid/non-Linear projects) issued by Deputy Commissioner as per guidelines issued by GOI, MOEF&CC, New Delhi vide F.No. 11-9/1198-FC (Pt) dated 05-07-2013 will have to submitted before the final approval under the FC Act.
