

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11- 9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that **84.4505** Ha. of forest land proposed to be diverted in favour of Project Director, PIU-Khandwa, National Highway of Authority of India, Govt. of India for 4-laning of Boregaon Buzurg to Muktainagar Section of NH-753L From Ch. 139+000 to Ch. 216+000 (Length 77+000 Km) Under Bharatmala Pariyojana in the State of Madhya Pradesh is passing through villages of Dahinala, Hasanpura & Asir of tehsil Nepanagar and Village Jhiri of tehsil Burhanpur both in the district of Burhanpur.
