ORDER:

- 1.The Principal Secretary/ Managing Director, Tamil Nadu Slum Clearance Board Chennai has requested TWAD Board to provide about 10.00 lakhs Litres/Day (1mld) from MullurVilakku Booster sump under CWSS to 1751 habitations in Pudukkottai vide Letter Dated 28.06.2018. After considering the feasibility , it has been informed vide Executive Engineer, TWAD Board, Project Division Letter Dated 12.07.2018 that only 0.70 MLD of water can be allotted to TNSCB. TNSCB has also given Concurrence to accept the available quantity of 0.70 MLD vide letter dated 20.09.2018 & 02.01.2019.
- 2.The Principal Secretary/ Managing Director, Tamil Nadu Slum Clearance Board Chennai remitted the upfront amount of Rs.7.00 Lakhs on 23.01.2019.
- 3.The Chief Engineer, TWAD Board, Thanjavur, prepared DPR for Providing 0.70 MLD Water supply to TNSCB HFA (Housing For All) Project Area for 1920 Tenements at Narimadu of Pudukkottai District Under Industrial demand of CWSS to 1751 Habitations in Pudukkotai District at an estimated cost of Rs.3.17 crore to install and Rs.12.60 Lakhs to maintain annually.
- 4.The proposal was cleared by the Regional Technical Committee on 18.01.2019 and by State Level Technical Committee on 13.02.2019.

5.Managing Director, Tamil Nadu Slum Clearance has remitted their project cost of Rs.3.10 Crore (excluding investigation charge of Rs.7.00 Lakh) on 02.07.2019.

6.MOU have been concluded by TWAD Board with the Superintending Engineer, Tamil Nadu Slum Clearance on 27.08.2019.

7.The Government of Tamil Nadu vide Gazette Notification dated 18.05.1977 published an amendment to TWAD Board Act:1970, in sequel to the orders promulgated in G.O.(Ms) No.776/ RD&LA Department dated 03.05.1977, authorizing TWAD Board to accord Administrative Sanction for proposals for which the local body or other institutions or person for whom the scheme is to be formulated agrees to bear the entire cost of the scheme without seeking assistance for loan or grant from Government.

8.Accordingly, the subject was placed before the Board and Board vide resolution No. 2.2, dated 17.09.2019, **RESOLVED** to accord Administrative Approval to the proposal for Providing 0.70 MLD Water supply TNSCB HFA (Housing For All) Project Area for 1920 Tenements at Narimadu of Pudukkottai District from Mullur Vilakku sump of CWSS to 1751 Habitations in Pudukkotai District, prepared at an estimated cost of Rs.3.17 Crore to install and Rs.12.60 Lakh to maintain annually to implement the scheme with 100% deposit work. The revenue to Board will be Rs.25.35 Lakh per Annum.

9.Accordingly, Administrative Sanction is hereby accorded to the proposal for "Providing 0.70 MLD Water supply to TNSCB HFA (Housing For All) Project Area for 1920 Tenements at Narimadu of Pudukkottai District Under Industrial demand of CWSS to 1751 Habitations in Pudukkotai District at an estimated cost of Rs.3.17 crore to install and Rs.12.60 Lakhs to maintain annually to implement the scheme with 100% deposit work".

10. The Chief Engineer, TWAD Board, Thanjavur shall soon accord Technical Sanction, after updating, the Detailed Project Report to the current Schedule of Rate (2019- 2020) and take up the scheme for implementation duly satisfying the governing rules, regulations and allied procedures. The Chief Engineer, TWAD Board, Thanjavur is instructed to collect the balance project cost if any before taking up the work.

11. The Scheme on completion upto the TNSCB sump at Narimedu, will be maintained by TWAD Board.

12. The beneficiary is liable to remit water charges at the prevailing rate of Rs. 9.92/KL subject to variation from time to time as decided by TWAD Board.
