Since this line is connecting an existing line (i.e. 400 kv D/C Mandola- Bawana T/L) with existing S/S (i.e. 400/220 Kv Maharanibagh S/S). Accordingly, no additional work neither any S/S nor bus reactor shall be required/ taken up in this system. Hence no additional forest land/area is required associated with this system. Proposed land is sufficient and final for this project.
